NOW IT IS HEREBY AGREED as follows:

1. As an inducement for the College, from time to time extend credit to _____
_____ (the “Student”), it is hereby agreed that the Guarantor does hereby guarantee to the
College the prompt, punctual and full payment of all monies including service charge, penalties now or hereinafter
due to the College under the CAS/Visa Letter (for the whole period) and all the fees due from the Student for duration
of his studies at the college. I guarantee to pay 50% fee of each year on issue of CAS and 50% on enrolment or any
other payment plan agreed by the college.
2. Until termination, this guarantee is unlimited as to amount or duration and shall remain in full force and effect
notwithstanding any extension, compromise, adjustment, forbearance, waiver, release or discharge of any party or
guarantor, or release in whole or in part of any security granted for the said indebtedness or compromise or adjustment
thereto, and the Guarantor waives all notices thereto.
3. The obligations of the Guarantor shall at the election of the College be primary and not necessarily secondary and the
College shall not be required to exhaust its remedies as against the Student prior to enforcing its rights under this
guarantee against the Guarantor.
4. The guarantee hereunder shall be unconditional and absolute and the Guarantor waives all rights of subrogation and
set-off until all sums due under this guarantee are fully paid.
5. In the event payments due under this guarantee are not paid punctually upon demand, then the Guarantor shall pay all
reasonable costs and solicitors’ fees necessary for the collection and enforcement of this guarantee.
6. This guarantee may be terminated by the Guarantor upon fourteen (14) days written notice of termination being
delivered to the College and all the fees due under the guarantee has been paid.
7. The Guarantor warrants and represents it has full authority to enter into this guarantee.
8. This guarantee shall be binding upon and inure to the benefit of the parties, their successors and assigns.
9. This guarantee is subject to English law and the parties agree to submit to the exclusive jurisdiction of the English
courts in connection with any dispute hereunder. The college has a discretion to issue proceedings in other
jurisdictions for recovery or any enforcement action.
10. I have substantial means to cover and support the student’s study in the UK, fees, living expenses, return air fares and
all the other expense required from time to time by the student during his course of studies with the college.
